Membership Definitions

All Memberships are for individuals, not companies or agencies. Your membership entitles you to specific benefits and privileges not available to non-members.

Regular Member: Any individual who lives in the United States or Canada responsible for the administration (specification, purchase or lease, maintenance, disposal, etc.) of a motor vehicle fleet (automobiles, SUVs, trucks, vans and/or a wide range of specialized mobile equipment) who is employed by a company or government agency and who is not engaged in the sale, rental or lease of, or service to, motor vehicles.

International Regular Member: Any individual who lives outside of the United States and Canada responsible for the administration (specification, purchase or lease, maintenance, disposal, etc.) of a motor vehicle fleet (automobiles, SUVs, trucks, vans and/or a wide range of specialized mobile equipment) who is employed by a company or government agency and who is not engaged in the sale, rental or lease of, or service to, motor vehicles.

Web Subscriber

Any individual residing outside of the United States and Canada or any fleet professional (not a company or agency) who is eligible to be a NAFA Regular Member with a fleet less than 25 vehicles, and wishes to receive complete access to NAFA's website and the information it features.

Associate Member: Any individual not eligible for Regular Member status but who has a direct interest in motor vehicle fleet administration through the supply of products and/or services directly pertaining to the industry and who supports NAFA and subscribes to its aims and purposes.

Student Member (as noted in the Code of Regulations as "Junior Member"): Any Regular-time (12 credit minimum), matriculating student who is pursuing a course of study which encompasses the aims and objectives of NAFA, and who also does not meet the criteria for a Member or Associate. Education must be at college level or a trade/tech school that is post-high school. Student membership may be limited to set number of years as determined by NAFA. Relevant course of study as to be determined by NAFA.
